What is this medicine?

Testosterone (tes-TOS-ter-one)

- Testosterone is a sex hormone derived from yams and may be given to men and some women who no longer produce a sufficient amount on their own.
- Testosterone is an anabolid steroid.
- In men, it may be used to reduce the symptoms of male hypogonadism (erectile dysfunction, infertility, decrease in beard and body hair growth, decrease in muscle mass, development of breast tissue, or loss of bone mass).
- It may also be used for other conditions as determined by your doctor.

Compounded Drug Forms: BLA tablet, sublingual tablet, fast-burst sublingual tablet, troche, vaginal suppository, vaginal tablet, cream, gel, suspension

What should I tell my health care provider before I take this medicine?

- Allergy to testosterone
- Male and have breast or prostate cancer
- Have heart disease, kidney disease, or liver disease
- Pregnant or may be pregnant, or breastfeeding

How should I use this medicine?

Follow the package directions provided by Belmar Pharmacy and by your prescriber. Your dosage is based on your medical condition and response to therapy. Follow the dosing schedule provided carefully.

Oral tablets may be taken with or without food, if it upsets your stomach take it with a small meal.

Sublingual tablets and fast-burst sublingual tablets should be placed under the tongue or between the cheek and gums and held in place until fully dissolved. Avoid swallowing saliva to ensure best absorption into the blood stream. Avoid eating or drinking 15 minutes before or after taking sublingual tablet.

Topical products can be applied to the inner arm, upper thigh, back of the knee, tops of feet and inner wrists. It is recommended to rotate sites to ensure even retention of the hormone. Cover treated skin with clothes to avoid contact with children's or women's skin.

Vaginal tablets or suppositories should be inserted using your finger or the applicator provided. Suppositories may leak, and may be more convenient to use at bedtime.

What if I miss a dose?

- If you miss a dose take it as soon as possible.
- If it is almost time for your next dose, skip the missed dose and continue with your regular dosing schedule.
- Do not take double the dose at once.

What should I watch for while using this medicine?

Belmar Pharmacy recommends yearly checkups with your provider.

What side effects may I notice from receiving this medicine?

Possible side effects that may occur and may go away as your body gets used to the medication include:

- Headache
- Acne
- Diarrhea
- Emotional instability
- Loss of strenth and energy
- Trouble sleeping
- · Changes in hair growth
- Deep voice (females)

Irritation at the site of topical application

Serious Side Effects: Contact your doctor immediately or seek medical attention if you experience:

- High blood pressure (e.g., bad headache, dizziness, fainting, or change in eye sight)
- Signs of high calcium levels (e.g., weakness, confusion, feeling tired, headache, constipation, bone pain, vomiting, or upset stomach)
- Erections that happen often or last a long time (males)
- Passing urine more often or trouble passing urine
- Change in how you act
- Enlarged/painful breasts
- Trouble breathing while sleeping
- Change in the color of your skin
- Shortness of breath
- Weight gain
- Swelling in the arms or legs
- Change in size/shape of testicles (males)
- Signs of a blood clot like chest pain or pressure: coughing up blood; trouble speaking or swallowing; swelling, warmth, numbness, change of color, pain in leg or arm
- Weakness on 1 side of the body
- An allergic reaction to this medication is unlikely but seek medical attention if it occurs. Symptoms of an allergic reaction include rash, itching, swelling, severe dizziness, trouble breathing.

Where should I keep my medicine?

Store at room temperature between 59 and 86 degrees F, unless otherwise specified on the packaging.

Additional Information:

- Do not share this medication with others to whom it was not prescribed.
- Keep out of reach from children and pets.
- If an overdose is suspected contact your local poison control center at 1-800-222-1222 or go to the nearest emergency room.
